
5. **Receive monthly report from the Treasurer and consider:**

Hired 5 new firefighters, they started October 1<sup>st</sup>. New hires came in for a 4-day orientation. A couple of volunteers from McDade stepped down. We had 249 fire calls for the month of September. Station 6 (McDade) call volume is up and response time is down. Two new command vehicles have arrived; one is being equipped with lights and equipment.
