Motion passed unanimously. Another motion was made by Commissioner Newstrom and seconded by Commissioner Skubiata to add a new budget line item for \$100,000.000 called New ESD Equipment fund. Motion passed unanimously. Finally, a motion was made by Commissioner Newstrom and seconded by Commissioner Skubiata to approve the fiscal year 2020-2021 budget of 725,000.00 for the ESD office.
